The remainder of the meeting was spent discussing the revised constitution and by-laws. A number of changes were agreed upon and will be included in the revised copy to be presented at the July meeting. At that time proposed changes will be voted upon.

Irene volunteered to serve as statistician for Varsity; it is assumed that Ken Bennett will continue in this role for the JV Division.

In order to acquire more newspaper publicity, Glenn will investigate the possibility of running a full-page ad in the Sunday paper. Ebbie will provide a news write-up for the season opening.

JV Division Play-Offs: Reverts to one division. Teams 1, 2, 3 and 4 must play the week of October 28.

Nominating Committee: Rich Mallow, Terry Waltz and Bill DuVall. Election to be held at November meeting.

1986 officials clinic will again be conducted by Bacon Miller and Jon Houser.

Individual teams will be responsible for paying for trophies for alternates at East-West game.

Ballots were cast for Coach of the Year.

Ebbie moved, seconded by Jon, that small awards be presented to John Sullivan, attorney, and Rick Twigg, sports writer. Motion carried.





Irene mentioned the possibility of using Bruce field, which has lights, for night games, playing three games a night, should time limitations at the end of the season require this. No action.


The secretary stated that all teams have paid the \$24 trophy assessment.

East-West and Championship Games: All coaches were advised to inform parents that they will be charged \$1.00 admission, non-playing students 50¢.


Awards Party: UCT will host; scheduled for October 29 at Mt. Savage Fire Hall, 7:00 p.m. Lawnie will have new certificates printed.

The regular monthly meeting of the JCP Soccer League was held on the above date at the LaVale Library. President Gregg Trexler called the meeting to order at 7:30 p.m.

Minutes of the September meeting were approved as distributed. Lawnie reported a bank balance of \$1,668.41, including proceeds from the end-of-season games. These were: \$113, Varsity Championship; \$53, JV Championship, and \$220, East-West games. Officials Fred Sloan and Bacon Miller were paid \$100 for officiating the two championship games. Officials Bacon Miller and Sonny Hunt donated their services for the East-West games. A bill for \$100 has been received from the Board of Education for use of lights at Beall Stadium for the Varsity Championship game. Ebbie will contact Mr. Martirano to endeavor to have this cancelled.

Annual Awards Party - Mt. Savage Fire Hall, October 29, 7:00 p.m., with Mt. Savage as host.

Future East-West and Championship Games - Ebbie recommended that in the future these should be played during the day; championship games both on Saturday and East-West games on Sunday on the same field; JCP coaches to act as officials. Motion to this effect was made by Mike Migdol, seconded by Ebbie, and carried unanimously.

Gregg suggested that all coaches discuss the problem of roughness at some of the games. Mike requested permission to bring in three nurses to discuss this, particularly the harmful effects of pushing. They will be invited to the November meeting.

Arnett addressed the condition of the George's Creek field, particularly the pitcher's mound, also the question of disputed calls at the George's Creek-Frostburg game. Ebbie suggested that, considering the problems Bill Blubaugh has been having in fielding and funding his team, he needs all the help and cooperation he can possibly receive from the other coaches.

Bill DuVall brought up the problem of dissension among JV coaches. Jon suggested that the JV's "get their act together" and follow the same system that the Varsity teams use.

addressed several issues for future consideration, as follows: 1) He had received a few complaints about the \$1.00 admission charge for the post-season games, but more than this were complaints about the lack of rest room facilities; 2) The treatment Flintstone cheerleaders received at the PVAA home game; 3) Lack of a ticket booth; and 4) Balls being raffled off at the Frostburg field by Frostburg sponsors at the East-West games with proceeds going to Frostburg team when it was not a Frostburg home game.

Larry Hurst remarked on the good job the coaches and League in general had done this year and thanked the League for making the program possible.
